That day, the unions had identified between 450,000 and 500,000 demonstrators through 144 rallies in France. The police put the figure at 224,000 (including 29,000 in Paris).-----

This day was followed, on 17 and 24 March events organized by youth organizations, but supported by four unions, and punctuated by a few incidents. March 31, CGT and Force Ouvrière hope topped the one million demonstrators across France

MINIMUM SERVICE WILL BE INSURED FOR METRO BUSES AND TRAINS-----

The strike call was relayed particularly in transport. At RATP, the first two unions, CGT and UNSA, call to stop work. South has not filed a notice but specific agents called for protests against the reform known El Khomri. Therefore, the RATP plans a second train on average in the A and B RER lines (including portions managed by SNCF) and three four metros. side bus and tram traffic should be "near-normal".

FRANCE IS UPSIDE DOWN UPON THE "EL KHOMRI LAW" ON LABOUR'S REFORM-----

The Collective of Association of the Public Service of territories among others, issued claims: "After the massive mobilizations with youth, 9, 17 March and 24 March, it must obtain the withdrawal from the labor bill by general strike and demonstrations on March 31 and end the multiple attacks that the public Service object.-----

To strengthen the rights of wage earners in the public sector or the private sector, withdrawal Labour Bill is essential all on strike March 31, 2016!-----

Indeed, the general status, special status and the 86-83 decree for non-permanent staff are essential elements of the collective rights of staff who already undergo questioning of their national character. Moreover, the austerity policy undermines the exercise of public duties and the purchasing power. Our union organizations also point out that the page is not of wage tour with the insufficient increase of 1.2%."
